#### **SUMMARY:**

I qualified as a Social Worker in 2011 with an MSc in Social Work. I have experience within the criminal justice and social work sectors and a proven track record of providing exemplary levels of service to a broad range of clients, including working with individuals with Autistic Spectrum Disorder, adults with physical disabilities, children, young people and families, within different settings. My experience has enabled me focus on assessing the risk, needs and best interest of children, young people and also adults. During my career I have also worked with Unaccompanied Asylum-Seeking Children (UASC) and their family's; supporting them as they arrive in the county, settling them into accommodation, assessing their needs and best interests, with regard to safety, risk, vulnerability and emotional wellbeing. I have also supported people through the asylum process by attending interviews with solicitors. I have experience of being the assessing social worker in Merton compliant age assessments and have acted as an appropriate adult in accordance with Police & Criminal Evidence Act 1984. To enhance my knowledge I have undertaken training with the Refugee Council.

I currently work as an independent social worker completing assessments and reports for local authorities, solicitors and private court cases. The fields I specialise in are

- Assess risk and safeguarding.
